- To be eligible, candidates must submit a 1-3 page typed essay describing the impact of the law enforcement member on the candidate's life.
- Candidates must be full time students with a current GPA of at least a 3.0.

- Scholarship is to be used exclusively for law school/university tuition and related academic expenses.

- Award recipient will be notified of the selection on or about September 30, 2015.
